

Overview:

This report provides summary information on all Requests for Proposal (RFPs) sent by Developmental Pathways (DP) for the entirety of Fiscal Year 2016 (7/1/2015—6/30/2016). The report summarizes RFPs sent for the following programs: HCBS-CES, HCBS-DD, HCBS-SLS, and State SLS. Data are current as of 11/10/2016.

Notes on These Data

The count of RFPs approximates, but does not precisely correlate, to the number of services requested; In FY16 there were 9 RFPs sent out requesting multiple services for the same client in a single request.

Additionally, our process to address RFPs that need to be resent (due to lack of responses or the individual's request to solicit additional responses) changed partway through the reporting period; initially, resent RFPs were tracked on a new line. The process has been changed to track up to three resends on the same line as the original request; this will better facilitate future reporting on the number of services needed and difficult-to-place services. For this year's reporting, however, the data are mixed, and reliable reporting on resent RFPs are not available.



Summary by Waiver


Number of RFPs Submitted



A total of 2867 RFPs were submitted in fiscal year 2016. Of those 2867 RFPs, 16% were sent for individuals on the HCBS-DD waiver, 45% were sent for individuals on the HCBS-CES waiver, and 39% were sent for individuals on the HCBS-SLS waiver. Further details on RFPs by waiver are reported below.



Percent of Individuals Placed with a DP Affiliated Entity




Of the 907 RFPs that resulted in placement with a provider, a total of 65 placements (7.17%) were with Continuum of Colorado, Developmental Pathways' affiliated entity.

Outcomes by Waiver



Of the 2867 RFPs that were submitted, a total of 907 (32%) were placed with a provider, 1053 (37%) were withdrawn, 816 (28%) resulted in no placement being found, 25 (1%) were left open at the request of the person in services and/or their family, and 66 (2%) were statewide RFPs.

Average Number of Days Between RFPs Sent to Providers and the Start Date of Services



For RFPs that resulted in placement, across all waivers there was an average of 113 days (approximately 3.7 months) between when the RFP was sent to providers and when the individual began services with the chosen provider. This span includes time for the providers to review and respond to the request; time for the case

manager to forward the responses to the person in services and/or their representative(s); time for the person in services to meet with, interview, and select providers; and time for the team to determine the amount/scope/frequency and duration of services and revise the service plan.

The data show that CES services take significantly longer to place and begin services. Anecdotal information suggests that this is due to families feeling overwhelmed and struggling to find the time to meet with providers and get services established. Additionally, there are likely provider capacity issues that exacerbate these timelines, as demonstrated by the no response rates later in this report.

Summary by Provider

This chart shows the frequency with which each provider was selected to provide services as a result of the RFP process, by waiver.



RFP No Response Reporting

Of the 2,801 RFPs sent (excluding 66 statewide RFPs), 612 received no positive responses. This chart shows which services had the highest rates of receiving no positive responses. Services with the highest percent of requests made are highlighted.

Requests made for Individuals with a SIS support level of 6 were most likely to receive no positive responses; there are no significant differences among the rate of no response among the other support levels. Because so few requests were made for individuals with a SIS support level of 7, no conclusions can be drawn from those data.

Requests for services made by individuals on the HCBS-CES waiver were most likely to garner no responses.


