

# **FAQ on the Intake Line**

# Where can I find IQ/adaptive testing?

Testing may be found in school IEP's, reports, and any past neurological/psychological assessments. Please contact your school to find out if adaptive or IQ testing has been completed. If not, please check with the school to see if they are planning on administering testing soon. If testing is needed outside of the school system, we can support with providing a list of testing resources. An individual's primary insurance may be able to cover the cost of testing if it is necessary.

# What is a confidence interval (CI) and why does the testing need to be completed at a 90% CI?

To qualify for services, an individual's IQ/adaptive score must be a 70 or below. The 90% confidence interval provides a range of values that you can be 90% certain contains the population mean (or the actual score). For example, if your child's adaptive behavior composite score is a 72 and the 90% CI indicates a range of 69-75, the confidence interval means the actual score is likely to fall somewhere between a 69 to a 75. This range allows us to use the lower end of your child's score which could be a qualifying score.

### Why is a re-determination required?

When a child turns five, the state changes the definitions of who qualifies and who does not. Prior to 5 an individual must meet delay criteria. After their 5<sup>th</sup> birthday, the child needs to meet the disability criteria. Therefore, Developmental Pathways must determine that the individual still qualifies for services based upon the child having a qualifying neurological diagnosis and IQ or adaptive test scores of a 70 or below.

## What can I get with Medicaid?

Everyone with Medicaid has access to basic Medicaid services/supports, known as State Plan Benefits. Depending on the type of Medicaid you have, that affects the additional services available. Some examples of basic State Plan Benefits include primary care services, Physical Therapy, Speech Therapy, Occupational Therapy, Behavioral Therapy, and Mental Health Services.
